TERMS & CONDITIONS The minimum age to volunteer at Living Love is 14 years old. Children between 14 and 17 years old must have a parent/guardian volunteer with them (the parent/guardian application should accompany the child's application). All Volunteers 16 and older must successfully pass a Criminal Background Check. Disqualifying Offenses include, but not limited to: Theft, Burglary, Arson, Breaking & Entering, Fraud, Any Drug-Related Offense, and Any Violent Offense (including Animal Cruelty). I hereby agree to serve as a volunteer for Living Love under the following terms and conditions: I will maintain high standards of humane, ethical behavior. I will perform my volunteer duties with honesty, self-discipline, and professionalism. I will maintain high standards of humane, ethical treatment towards all animals at Living Love. I will donate my services to Living Love without contemplation of compensation or future employment. I will adhere to sign-in and scheduling procedures set forth by Living Love, and agree to notify the Volunteer Services Supervisor when I am unable to work as scheduled. I will notify the Volunteer Services Supervisor if I choose to discontinue my volunteer services. I have current medical insurance coverage and agree to be responsible for any medical care that I must seek as a result of my volunteer service at Living Love. In the event that Living Love is not able to timely reach my Emergency Contact, I authorize Living Love to seek emergency medical treatment for me in case of an accident, injury, or illness. I agree to report all injuries, bites and scratches that draw blood, immediately to a staff person. I am medically, physically, and psychologically fit to work safely with animals and the public. I acknowledge that during my volunteer services, I may become privy to private or confidential information regarding, but not limited to, Living Love, its employees, impounded animals and customers/clients. I hereby agree to hold all such information in the strictest confidence and shall not disclose or discuss such private or confidential information with any third party. I understand the behavior of animals is sometimes unpredictable and some animals are capable of inflicting disease, serious personal injury, death or extensive property damage. I understand that my volunteer activities on behalf of Living Love may place me in a hazardous situation and could result in injury to me or my personal property. I agree to indemnify, defend and hold Living Love, and its agents, officers, directors, and employees free and harmless from all liability arising out of any and all claims, demands, losses, damages, action, judgments of every kind and description that may occur to or be suffered by me by reason of activities arising out of this Agreement. I further agree to indemnify, defend, and hold Living Love, its agents, officers, directors, and employees harmless from and against any and all claims, demands, liabilities, causes of action, damages, costs (including reasonable attorneys' fees and disbursements) and judgments made or incurred by or found against them, resulting from or arising out of: (i) any breach or default by me of any term or provision of this Agreement; or (ii) any negligent or willful act or omission by me with respect to my services pursuant to this Agreement. I understand that the Living Love, without notice or hearing, may terminate my volunteer position at any time, for any reason, with or without cause; provided, however, my confidentiality and indemnification obligations shall survive such termination.
